Fees are charged for our Primary, Central and Secondary schools in the Catholic Dioceses of Armidale.

In addition to tuition fees, there may be school-based charges for specific subjects, excursions or other activities.

Armidale Catholic Schools recognises that all students are entitled to access educational opportunities that nurture the Catholic faith and allow students to reach their full potential. Armidale Catholic Schools work together to ensure literate and numerate students for a hope-filled future.

Armidale Catholic Schools endeavours to offer an affordable Catholic education of the highest quality. There is a deeply held commitment at all levels (Diocese, System, Parish and School) that no Catholic family should be denied a Catholic education due to a genuine incapacity to pay all, or part of their children's school fees. Armidale Catholic Schools receives funding from both Commonwealth and State Governments which is necessary to operate our schools. School fees supplement the income received from the Commonwealth and State Government and are essential to help meet the gap between government funding and the cost of providing quality educational experiences and outcomes for students.

## Terms of Payment

School Fees are billed on an annual basis at the commencement of the School Year and our standard payment terms are 10 monthly installments from February to November.

Parents are issued an annual Tax Invoice/Statement in Term One with monthly statements issued thereafter.

## Family discounts

2nd Child: 15% Discount on the 2nd child's tuition fees only.

3rd and Subsequent Children: 30% Discount on the 3rd and subsequent children's tuition fees only.

## Payment

Our preferred method is BPay. We also accept the following payments - Compass Payment Centre, Credit Card or EFTPOS. If you wish to pay by BPay please use your Biller Code number that appears on your fee statement as a reference.

Please note that families are able to pay for the fees via regular payment periods, such as monthly, fortnightly or weekly.

Families experiencing hardship may also contact the School to enter into alternative payment arrangements.
